at MA. Day one was spent on Capital Hill, joined by more than 30 Delaware nurses to advocate for restricting mandatory overtime, Nurse Faculty Shortage Reduction Act (H.R. 7002, S. 2815), Improving Care and Access to Nurses (ICAN) Act (S. 2418, H.R. 2713) and to protect timely access to quality nursing care in long-term care facilities. Congresswoman Lisa Blunt Rochester heard directly from Delaware nurses on these topics.

On day two, representatives from state nursing associations and ANA leaders gathered to discuss and hear vital issues from nurses affecting the profession. The first dialogue forum focused on the impact of licensure and employment practices on nurse's mental and emotional well-being, including how to eliminate barriers. The second forum addressed care coordination and collaboration for veterans receiving community care, ensuring access to care and nurses prepared to provide care. The third forum focused on the comprehensive revision

of the Code of Ethics for Nurses with Interpretive Statements. State nursing associations were asked to provide comments on the proposed changes.

We heard from ANA's interim CEO, Angela Beddoe, on an enterprise initiative in which we envision ANA in 2040 and closing the gaps to prepare us for the future. Her bold vision includes ensuring nurses have "best in class practices, innovation, engagement, education, research, programs, and financial vitality." This address was a powerful and forward message with eyes fixed on a destination the ANA hasn't seen before and we are excited for it.

On day three, the voting body moved to support the work on the dialogue forums from the previous day. In addition to this, a motion was made and approved on transparency in investments and ethical partnerships. This work confirms that nurses are activists and change makers. This is an exhilarating time for the work of the nursing profession and

for ANA and state nursing associations to be positioned to make a greater impact that ever. New ANA Board of Director members were elected and announced. Those include:

Nurse Advocacy in Action: Your Voice Matters!

June is always a busy month. It is the month that DNA hosts our annual

"Nurse's Day at Legislative
Hall" in Dover, ANA's Hill
Day in Washington, the end
of Delaware's legislative
session, and the ANA Membership Assembly. This June,
Delaware's nurses made an impact!

Over 20 LPNs, RNs, and APRNs participated in DNA's day at Legislative Hall in Dover. Over a dozen constituent meetings were held, with nurses advocating for multiple topics. Nurses got to meet with DE's three nurse legislators, too, Lt. Governor Dr. Bethany Hall-Long, House Majority Leader, Representative Melissa "Mimi" Minor-Brown, and Representative



Valerie Jones-Giltner. These nurses made an immediate impact on the legislative process.

House Bill 140, end of life options/death with dignity,

was passed out of committee the following day and eventually passed both chambers. House Bill 401, school nurse access to lead screening status and results, passed on the House consent agenda and eventually passed the Senate. Senate Bill 195, programmatic support and funding for DMOST, passed out of Senate committee and eventually passed both chambers.
